(The \$680 Academic Fee covers textbooks, technology, library, diocesan fees, yearbook, testing expenses, Home & School fee, Extra Care fee and others.)

1. Each payment is withdrawn in full on the 5<sup>th</sup> or the 20<sup>th</sup> of the month. If the 5<sup>th</sup> or 20<sup>th</sup> falls on a Saturday, Sunday or bank holiday, the payment is withdrawn on the following business day.
2. An unpaid tuition payment becomes delinquent 30 days after the due date. A late fee of \$40.00 per month may be assessed on all delinquent tuition. (the \$40 late fee is additional to the FACTS Company \$25 late fee). Payment will be applied to late fees first; the balance of the funds will be applied to tuition.
3. If your tuition account is not current by the last day of the month the student can not attend class the following day until the account is made current.
4. Tuition that is two months delinquent may result in:
  - 1) the balance of the account will be required to be paid in full, or
  - 2) the permanent removal of your child(ren) from St. Ann School.
5. In the event that the undersigned fails to pay the obligations under the terms of this agreement on a timely basis the undersigned agrees to pay all the expenses of collection including collection agencies, attorneys, courts and all other legal and valid collection expenses.
6. If a student withdraws from school for any reason (moving, expulsion, etc.), a refund will be based on remaining academic quarters. Fees are non-refundable.
7. All transcripts, report cards, student records and diplomas are the property of St. Ann Catholic Church and will not be issued to current, transferring, or graduating students until all tuition is paid in full.
